THE EILAND LAW FIRM'S MOTION FOR AWARD OF ATTORNEYS' FEES AND REIMBURSEMENT OF EXPENSES

The Law Offices of A. Craig Eiland, PC (the "Eiland Law Firm"), pursuant to this Court's Order Preliminarily Approving the Settlement in this case and dated April 10, 2018 and Federal Rule of Civil Procedure 23, hereby moves the Court for an award of its attorneys' fees and recoverable costs and expenses. The Eiland Law Firm seeks payment of the contractually agreed upon fees and expense reimbursement between the firm and all clients who receive a settlement award. The Eiland Law Firm respectfully asks the Court to pay any attorney fee and expense award from the fund created to pay attorneys' fees and expenses arising out of the preliminarily approved Syngenta litigation settlement (the "Fund"). In the alternative, if the Court sets aside the contingency fee agreements between the Firm and its clients, the Eiland Law Firm seeks payment
