**MEMORANDUM IN SUPPORT OF HOSSLEY-EMBRY PLAINTIFFS’ COUNSEL’S
MOTION FOR AN AWARD OF ATTORNEYS’ FEES**

TO THE HONORABLE UNITED STATES DISTRICT COURT:

Attorney, Allen Hossley of Hossley-Embry, LLP, and behalf of its co-counsel, Redenbaugh & Mohr, PC, of Storm Lake, Iowa file this Memorandum in Support of their Motion for an Award of Attorneys’ Fees, and respectfully state the following:

THE HOSSLEY-EMBRY PLAINTIFFS’ COUNSEL’S WORK

The Hossley-Embry law firm began filing its first cases on behalf of the corn producer farmers against the Syngenta Corporation and the other Defendants back in approximately October of 2015 in the United States District Court for the District of South Dakota, Northern Division and shortly thereafter, in November of 2015, Hossley-Embry along with its co-counsel, Redenbaugh & Mohr of Storm Lake, Iowa began filing individual producer lawsuits in the United States District Court Northern District of Iowa Western Division.¹ Since its first filings,

Hossley-Embry with its co-counsel have filed over 650 individual corn producing farmers' cases, each with their own separate cause number. All of these individually filed cases are now pending before this Honorable MDL Court. For every client represented by Hossley-Embry and its co-counsel, each client entered into a 33% contingency fee agreement with Hossley-Embry.² Moreover, Hossley-Embry Plaintiffs' counsel agreed not to charge their clients any expenses related to the litigation of their claims. Simply put, Hossley-Embry counsel has a straight one-third two-third's agreement with each and every client they represent. To date, and pursuant to the Hossley-Embry fee agreement, Hossley-Embry and its co-counsel have not been compensated for representing their clients and will only be compensated upon the clients' recovery under the settlement.

During the course of this litigation, the Hossley-Embry Plaintiffs produced two of the bellwether plaintiffs in the Federal MDL proceeding, both of whom, with the full assistance of the Hossley-Embry law firm, participated in the discovery process, including responding to discovery and producing the plaintiffs for their depositions.

Hossley-Embry counsel and its Plaintiffs have been actively involved in the work up of their individual cases not to mention the overwhelming amount of expenses incurred since 2014 on behalf of each corn producer plaintiff. Additionally, the Hossley-Embry Plaintiffs' counsel spent countless time with each of their clients, their local Farm Services Administration (FSA) offices, local crop insurance agencies, and other local elevators, ethanol plants, and seed sales offices to provide all of the supporting documents as required by the Court. Hossley-Embry counsel monitored pleadings, attended the MDL hearings and status conferences, and maintained regular updates to each of its clients.

After the litigation settled in September of 2017, Hossley-Embry Plaintiffs' Counsel,

individually and with co-counsel, have spent and will continue to spend into the future thousands of man-hours in preparing their clients' claims for filing, including but not limited to, speaking to clients over the telephone, sending letters to every client, scheduling and meeting with each and every client regarding their claim form, working with the clients' crop insurance representatives and local FSA officers to ensure the accuracy of each and every client's claim form.

WHEREFORE, the Hossley-Embry Plaintiffs respectfully request the Court to allow the Hossley-Embry Plaintiffs to (i) honor the contingent fee contracts they have with Hossley-Embry and its co-counsel, (ii) award Hossley-Embry their contractual contingency fee pursuant to the fee agreement with each of their clients, and (iii) grant them such other and further relief to which they are justly entitled.

33% contingency fee agreement. This agreement only allows my firm and its co-counsel to receive fees only if the client is awarded a recovery. Moreover, Hossley-Embry Plaintiffs' counsel agreed not to charge their clients any expenses related to the litigation of their claims. Simply put, Hossley-Embry counsel has a straight one-third two-third's agreement with each and every client they represent.
