#### MEMORANDUM IN SUPPORT OF MOTION OF PAVLACK LAW, LLC, ON BEHALF OF ITSELF AND ITS CLIENTS, AS WELL AS ASSOCIATED FIRMS, FOR **AWARD OF ATTORNEY FEES AND REIMBURSEMENT OF COSTS**

#### I. Introduction

Each of Pavlack Law, LLC's clients retained Pavlack Law, LLC and its co-counsel<sup>1</sup> (collectively the "Firm") to represent them in this case. This suit is subject to a certified class action, entitling the Firm to reasonable attorneys' fees as authorized by both Rule 23(h) of the Federal Rules of Civil Procedure and Rule 23.08 of the Minnesota Rules of Civil Procedure. BThe Firm is entitled to be compensated for its substantial time and risk given the complexity and novelty of the legal issues involved and the substantial settlement reached. The fact that the

Paylack Law, LLC's co-counsel on each of the cases it filed is the Indianapolis law firm of Wagner Reece, LLP; the law firm. Indiana lawyers Wayne Lennington and Pen Cosby are additional co-counsel on some, but not all, of Pavlack Law's cases.

Firm was not designated as Class Counsel is not determinative as to which counsel are entitled to fees or costs. As the Tenth Circuit noted in *Gottlieb v. Barry*:

We fail to see why the work of counsel later designated as class counsel should be compensated, while the work of counsel who were not later designated class counsel, but on whose shoulders class counsel admittedly stood, should be wholly uncompensated.

43 F.3d 474, 488 (10th Cir. 1994).

#### II. Argument

#### A. Summary of Litigation and the Firm's Clients

The Firm's clients entered into Legal Service Agreements (the "Agreements") with the Firm between December 2015 and August 2016, regarding their claims against Syngenta. A true and accurate list of each of the Firm's clients is attached as Exhibit 1 to this pleading; [Exhibit 4 (hereafter "Pavlack Decl.") at ¶ 4]; [Exhibit 5 (hereafter "Reese Decl.") at ¶ 4]. The Agreements set forth that the Firm would advance court costs and litigation expenses. [Pavlack Decl. at ¶ 5]; [Reese Decl. at ¶ 5]. In other words, the Firm was not compensated up front for the representation of its clients and would be compensated only upon a recovery by the client. [Id.].

The Firm incurred substantial costs and litigation expenses in pursuit of its clients' claims. [Exhibit 3]. On top of that, the Firm anticipates that its work is not done now that there is a Settlement Agreement. [Pavlack Decl. at ¶ 15]. In fact, the Firm will continue to work and represent and advise our clients until they are compensated. [*Id.*]. Put plainly, when previously retained clients subsequently join a class action they generally continue to contact their attorney for advice on settlement forms and documents. The Firm and other independently retained

contingent fee counsel devoted a large amount of resources to this litigation despite considerable risk.

Although the Firm started signing clients in December 2015 and filing lawsuits by April 2016, [id. at ¶ 11], this Court (the "MDL Court") did not certify this case as a class action until September 26, 2016 [Doc. 2547]. The MDL Court did not issue its "Order Appointing Plaintiffs' Settlement Negotiation Committee in the Syngenta Litigation" until August 9, 2017 [Doc. 3366], and the Court did not preliminarily approve the certified class settlement until April 10, 2018 [Doc. 3532].

#### **B.** Prosecution of the Litigation

After transfer to the MDL, the Firm continued to do what it was retained and required to do: represent its clients throughout the course of litigation. This remained so even after the Court's appointment of Co-Lead Counsel and the Plaintiffs' Executive Committee (the "PEC") on January 22, 2015. [Doc. 67]. Even after the Court's designation of Co-Lead Counsel and the Plaintiff's Executive Committee, the Firm was not informed that it should stop performing work on behalf of its clients or that it would not be compensated for the work performed, or expenses incurred.

Indeed, early on, the MDL Court recognized legitimate, competing interests between class and individual claims. In the January 22, 2015 "Order Concerning Appointment of Counsel", at page 2, the Court noted as follows:

The court was especially impressed by the extent to which their lawyers had thought through the matter of advancing the interests of diverse groups of plaintiffs and built a team which takes those interests into account. Some of the plaintiffs in this case desire to proceed by individual actions. Others prefer the certification of one or more classes. Still others seek or will seek remand to state court. Some of the plaintiffs are large entities, others operate small farms. The DCPS group alone included representatives of each of these interests in its leadership team, including its proposed Executive Committee. Not only does the court agree that this is the

best way to proceed, but it believes that it bodes well for the expeditious handling of this litigation that the DCPS group anticipated this diversity and proposed an organization accordingly.

In that same order, the MDL Court noted Plaintiffs' co-lead counsel's duties, *inter alia*, "to encourage full cooperation and efficiency among all plaintiffs' counsel." The August 5, 2015 Minnesota Litigation Order appointing leadership, at page 3, contains substantially similar duties as those listed in the MDL order including the duty to encourage full cooperation and efficiency among all plaintiffs' counsel. In this same Minnesota order, the Minnesota Court appointed Robert Shelquist as Liaison Counsel and authorized him to, *inter alia*, "convene meetings of counsel as necessary [and] advise parties and attorneys of developments in the litigation . . ."

These Court orders are consistent with the Manual for Complex Litigation which requires liaison counsel to convene meetings of counsel, advise parties of developments, and other matters. *Man. Complex Lit.*, 2018, Section 10.221. The orders are also consistent with leadership duties, generally, to "fairly and adequately represent all of the parties on their side" and "to act fairly, efficiently, and economically in the interest of all parties and parties' counsel." *Id.*, at Section 10.22.

# C. Independent Counsel Devoted Substantial Time, Risk and Effort to this Litigation.

In 2015, the law firm of Wagner Reese was contacted by several farmers interested in pursuing claims for China rejecting shipments of corn from the U.S., which caused a price drop in the value of corn. After researching the case, the Wagner Reese began hosting a series of town hall meetings to speak with farmers and sign contingency fee agreements for prosecution of their claims. Wagner Reese teamed up with Pavlack Law to file cases in the Minnesota proceedings on behalf of these clients, which resulted in Pavlack law filing four multi-plaintiff cases on behalf of a total of 49 plaintiffs.

Starting in 2016, after the Plaintiff Fact Sheet order was entered, the Firm spent hours contacting and meeting with farmers to obtain the documentation required by the order, knowing that if the information was not produced by the court deadlines, defense counsel could file a motion to dismiss the individual cases barring our clients from ever recovering. [Pavlack Decl. at ¶ 13]. After the long discovery process and monitoring the status of the bellwether cases around the country, our firm became aware in September 2017 about the potential settlement of all cases around the country. [*Id.*]. With the understanding there was settlement committees comprised of both individual and class action attorneys, it was believed there would be two settlement tracks. [*Id.*]. In early 2018 we became aware there would be only one Class Actions Settlement encompassing our filed cases and we began advising clients of the Settlement and what we believed was in their best interest. [*Id.*].

Throughout this process, the Firm filed pleadings, investigated the underlying facts of their individual cases, conducted research, reviewed the copious filings regarding this litigation, attended this Court's hearings and status conferences, and spent numerous hours explaining to class members all that was occurring along the way. [*Id.* at ¶ 14]; [Reese Decl. at ¶¶ 14–15]. The Firm devoted significant time and effort through the course of this litigation to pursue the claims of its clients.

The Firm believes the settlement is fair and in the best interests of our clients and we have recommended to our clients that they participate in the class action settlement. [Pavlack Decl. at ¶ 15]. Accordingly, the vast majority of the Firm's clients have chosen to participate in the class action settlement. [Id.]. Thus, in addition to prior time spent litigating the case and advising clients, the Firm has—and will continue—to assist class members with the settlement process. Id. In short, there is still much more class member hand-holding to do as the settlement

process unfolds over the following months or years as clients generally contact their attorney for advice as to any class related materials they may receive. [*Id.*].

The Firm is responsible for dozens of class members, and communications have increased and are expected to increase again as the settlement becomes operational. Unless the court awards attorneys' fees, independent counsel will have to continue to represent their clients for the following months or years without pay or terminate its representation. Put simply, there is no justification for treating class counsel work differently from non-class counsel work under this scenario.

Courts have held that the primary factor that should be considered in awarding attorney's fees is the risk of no recovery that counsel shoulders. *See*, *e.g.*, *Ketchum v. Moses*, 24 Cal. 4th 1122, 1132 (Cal. 2001). Independent counsel prosecuted this case on a wholly contingent basis knowing that the litigation can (and did) last for years and would require devotion and a substantial amount of attorney time and significant advance of litigation expenses with no guarantee of compensation. On top of this, because of the size and scale of this litigation, a high degree of skill and efficiency was required to successfully prosecute this matter.

The undersigned, as well as the majority of non-class counsel in this case, worked for years before a class settlement was reached in this case. As such, the Firm deserves to have its fee contracts honored and paid from the settlement Fund. Indeed, class counsel did not incur the risk of several years' work educating farmers and signing clients with no guarantee of success. The years spent litigating this case makes it significantly dissimilar to the Volkswagen class action and the non-class counsel fee requests in that case. In the Volkswagen class action, plaintiffs' leadership was appointed on January 21, 2016, and the Court filed its preliminary approval of a class action settlement on July 29, 2016, a mere seven months later. Here, almost

three-and-one-half years passed between the MDL Court's appointment of leadership and the court's preliminary approval of the settlement.

## D. Independent Counsel's Efforts Conferred Direct and Tangible Benefits to the Class

The United States Supreme Court "has recognized consistently that a litigant or a lawyer who recovers a common fund for the benefit of persons other than himself or his client is entitled to a reasonable attorney's fee from the fund as a whole." *Boeing Co. v. Van Gemert*, 444 U.S. 472, 478 (1980); see, also, *Sprague v. Ticonic Nat'l Bank*, 307 U.S. 161 (1939) (when an attorneys' efforts benefit a common fund, the court is empowered to award fees from the fund). To prevent unjust enrichment, courts exercise their inherent equitable powers to assess attorneys' fees against the entire fund, thereby spreading the cost of those fees among everyone who benefited. *Sprague*, *supra*.

Furthermore, Rule 23(h) of the Federal Rules of Civil Procedure (as well as Rule 23.08 of the Minnesota Rules of Civil Procedure) authorizes awards of reasonable attorneys' fees in class actions. ("In a certified class action, the court may award reasonable attorney's fees and nontaxable costs that are authorized by law or by the parties' agreement."). This is true even if the applicant seeking attorney's fees was not designated class counsel. According to committee note to subsection Federal Rule 23(h):

[This rule] provides a format for all awards of attorney fees and nontaxable costs in connection with a class action, not only the award to class counsel. In some situations, there may be a basis for making an award to other counsel whose work produced the beneficial results of the class, such as attorneys who acted for the class before certification but were not appointed class counsel . . . .

Along these lines, the Tenth circuit held that non-designated counsel may be entitled to attorney fees in class actions where the non-designated counsel benefited the class as a whole. *Gottlieb*, *supra*, at 488. In *Gottlieb*, the District Court refused any award to non-designated

counsel on the grounds that their efforts did not contribute to the creation of the fund and that their failure to be designated as class counsel deprived them of any right to fees from the common fund. *Id.* at 486. In addition, the special master, found that work performed before class counsel was designated was duplicative of class counsel's work. *Id.* The Tenth circuit reversed the district court's decision holding "it seems implausible that all of sixteen months of work, pursued on multiple fronts by multiple counsel, suddenly becomes worthless upon the selection of a few counsel to serve as class counsel." *Id.*, at 489.

During the three-and-one-half years between the appointment of leadership and the preliminary approval of the class action settlement, the Firm and its attorneys spent hundreds of hours working on behalf of the Firm's clients. *See*, Exhibits 2 & 6. The work of the Firm and other non-Class Counsel maintained pressure on Syngenta as this years-long litigation wound its way to settlement negotiations. That process included consulting clients, the completion of thousands of plaintiff facts sheets and an extensive bellwether process, all of which provided information needed for settlement along with continued pressure on the Defendants.

This litigation required on-going and immense efforts of those involved. The resources of our Firm have been used to contact and consult with Class Members as they completed their Plaintiff Fact Sheets and to help them gather information for the settlement and to answer their questions regarding the case, and now, the preliminarily approved settlement. It is not unusual for any one such call to take 30 to 60 minutes of attorney or paralegal time. The Firm anticipates that all of the Firm's clients will timely complete settlement submissions. [Pavlack Decl. at ¶ 15]. This is work and legal advice that would have been performed by Class Counsel had it not been performed by the Firm.

#### E. Attorneys' Fees Requested

Generally, the Firm's clients executed written fee agreements with the Firm with contingent fees ranging from twenty percent (20%) to forty percent (40%). [Pavlack Decl. at ¶ 4]; [Reese Decl. at ¶ 4]. Movants request that the agreed-upon contingent fee and expenses as to each of the Firms' clients be paid from the Fund to be created from the preliminarily approved class action settlement. In the first alternative, Movants request payment of fees equal to thirty-three and one-third percent (33 1/3%) of all amounts recovered by the Firm (along with its expenses) from the Fund. In the second alternative, Movants request that the Firm be compensated from the Fund for their hourly time and costs in this litigation along with all requested, but unreimbursed, common benefit time.³ Otherwise, Movants seek this Court's guidance as to what information it may need to evaluate the fee applications of non-Class counsel. Movants reserve the right to supplement this filing with such information as the Court may request.

In the event the Court requires the information at present, the hourly time and expenses incurred as to the Firm's clients are attached as Exhibits 2, 3 & 6 to this pleading. In total, the Firm has expended 365.9 hours of time, for a total of \$81,955.00 in attorneys' fees, and incurred costs in the amount of \$3,154.71 for the Firm's 49 clients. This is an average hourly fee of \$1,672.55 per claimant. As requested above, Movants seek an award of these expenses and this hourly time in the alternative to payment of its contingent fees. These rates are also fully justified by the skill, experience, and reputation of Plaintiffs' counsel.

The attached hourly billing summaries includes common benefit ("CB") time and non-CB time together. The Firm has submitted its CB time for consideration and obviously is not seeking double compensation for same. However, we do not know what portion of our requested CB time will ultimately be approved by the Court and we request compensation for any non-approved requested CB time as part of this fee application if hourly fees are awarded. In turn, we would not request payment for approved CB time through this application and would ask that the Court deduct any approved CB time from the calculations herein.

Mr. Pavlack is the managing attorney at Pavlack Law, LLC, and is admitted to practice in the State of Indiana. [Pavlack Decl. at ¶ 7]. Mr. Pavlack has over 19 years of experience in mass tort, class actions, and consolidated litigation that includes extensive experience in both state and federal courts. [*Id.*].

Mr. Pavlack has focused his practice on such cases over the past nineteen years, having represented dozens of classes in both local and national class action cases, and obtaining literally hundreds of millions of dollars for class members. *See*, *e.g.*, *In re Ready-Mixed Concrete Antitrust Litig.*, No. 1:05-CV-00979-SEB, 2010 U.S. Dist. LEXIS 85003, 2010 WL 3282591 (S.D. Ind. Aug. 17, 2010); *In re Iowa Ready-Mix Concrete Antitrust Litig.*, No. C 10-4038-MWB, 2011 U.S. Dist. LEXIS 130180, 2011 WL 5547159 (N.D. Iowa Nov. 9, 2011). [Pavlack Decl. at ¶ 7].

Wagner Reese, LLP was founded by partners Stephen M Wagner and Jason R. Reese in 2000. [Reese Decl. at ¶ 7]. The Firm handles personal injury, product liability, complex litigation, and class action matters throughout Indiana and Illinois. [Id.]. Mr. Wagner was admitted to the Indiana bar in 1994 and has taken numerous cases to jury trial throughout his career. [Id.]. He was named the Trial Lawyer of the Year by the Indiana Trial Lawyers' Association (ITLA) in 2006 and is an elected member of the ITLA Board of Directors. Jason R. Reese was admitted to the bar in 1997 and is currently licensed in Indiana and Illinois. [Id.]. Mr. Reese has extensive jury trial experience throughout his career and has been repeatedly recognized by his peers as one the best trial lawyers in Indiana. His recognition began in 2003 when the Indiana State Bar Association named him "Outstanding Young Lawyer of the Year." [Id.]. In 2016 and 2018, Mr. Reese's peers voted him a Top 50 Super Lawyer for the State of Indiana. [Id.].

**III. Conclusion** 

For the foregoing reasons, Movants respectfully ask this Court for payment of the fees

and expenses of the Firm's clients from the Fund. Movants also seek any additional guidance

from the Court as to information it may require to consider this request and accordingly seeks

leave to amend or supplement this pleading as may be necessary.

# DECLARATION OF ERIC S. PAVLACK FOR PAVLACK LAW, LLC IN SUPPORT OF MOTION OF PAVLACK LAW, LLC ON BEHALF OF ITSELF AND ITS CLIENTS AS WELL AS ASSOCIATED FIRMS FOR AWARD OF ATTORNEY FEES AND REIMBURSEMENT OF COSTS

- I, Eric S. Pavlack, declare as follows:
- 1. I am over the age of twenty-one years old and make this declaration based on my personal knowledge. If called as a witness, I could and would testify competently to the facts contained herein, which are true and correct.

- 2. I am the managing attorney of Pavlack Law, LLC (hereinafter "the Firm"). I am authorized to submit this declaration on the Firm's behalf.
- 3. I submit this declaration in support of the Motion of Pavlack Law, LLC on Behalf of Itself and Its Clients as Well as Associated Firms for Award of Attorney Fees and Reimbursement of Costs, (the "Motion"), filed pursuant to Section 7.2.1 of the Agrisure Viptera/Duracade Class Settlement Agreement (the "Settlement Agreement") in *In Re: Syngenta AG MIR 162 Corn Litigation*, a multi-district litigation consolidated in the United States District Court for the District of Kansas before Hon. John W. Lungstrum (MDL-2591), and *In Re: Syngenta Litigation*, a Minnesota Consolidated Proceeding consolidated in the Fourth Judicial District Court, Hennepin County, Minnesota, before Hon. Laurie Miller (formerly Hon. Thomas Sipkins) (File Nos. 27-CV-15-3785 & 27-cv-15-12625).
- 4. Together with Wagner Reese, LLP, Wayne Lennington, and Pen Cosby, the Firm represents 49 clients in the Argisure/Viptera litigation against Syngenta on a contingency basis. In written fee agreements, with three exceptions, each of these clients agreed to pay 40% of any recovery in this matter as a contingent fee, covering both legal fees, and further agreed to a division of those fees between the Firm and its co-counsels. Three clients, Craig Armstrong, Neil Armstrong, and C&N Armstrong Farms Ltd., have agreed to all of the same terms except that they agreed to pay 20% of any recovery.
- 5. As these were contingent fee agreements, our Firm advanced court costs and litigation expenses and would only be compensated if the clients recovered money.
- 6. Because my representation is on a contingency basis, I did not precisely track the time spent on this litigation since it was not anticipated this would be necessary. However, based on the review of my e-mails, notes, case management software, and other client and litigation

materials, I have retrospectively estimated my time spent on this litigation as set forth in this pleading and in my supporting Declaration. Any reference to dates in Exhibit 2 and Exhibit 3 are estimates based on the review of this information.

- 7. I was admitted to the Indiana bar in 1999, giving me nineteen years' experience practicing law. I have also been admitted to various Federal Courts. My main practice areas include mass torts, trial practice, products liability, personal injury, and class actions. I have focused my practice on such cases over the past nineteen years, having represented dozens of classes in both local and national class action cases, and obtaining literally hundreds of millions of dollars for class members. *See*, *e.g.*, *In re Ready-Mixed Concrete Antitrust Litig.*, No. 1:05-CV-00979-SEB, 2010 U.S. Dist. LEXIS 85003, 2010 WL 3282591 (S.D. Ind. Aug. 17, 2010); *In re Iowa Ready-Mix Concrete Antitrust Litig.*, No. C 10-4038-MWB, 2011 U.S. Dist. LEXIS 130180, 2011 WL 5547159 (N.D. Iowa Nov. 9, 2011).
- 8. The Firm spent a total of 179.4 hours on this litigation, which is \$57,655.00 at our usual and customary hourly rates. A true and accurate listing of the hourly bill generated by my firm is incorporated into Exhibit 2 to the Motion. A true and accurate listing of the expenses generated by my firm is incorporated into Exhibit 3 to the Motion.
  - 9. The Firm also incurred \$3,154.71 in expenses.
  - 10. The individuals in the Firm, other than myself, who worked on this matter are:
    - A. Eric S. Pavlack, managing attorney, admitted to practice in 1999, hourly rate \$600
    - B. Colin E. Flora, associate attorney, admitted to practice in 2011, hourly rate \$450
    - C. Robert Cooper, paralegal, hourly rate \$100
    - D. Stephen M. Wagner, Partner, admitted to practice in 1994, hourly rate \$450-\$700, depending on the matter
    - E. Jason R. Reese, Partner, admitted to practice in 1997, hourly rate \$450-\$700, depending on the matter
    - F. Katelyn Blankenship, litigation staff, hourly rate, \$75
    - G. Meg Spiker, litigation staff, hourly rate, \$75

- H. Gary Cauble, litigation staff, hourly rate, \$75
- 11. In December 2015, our Firm was contacted by several farmers who knew about China rejecting shipments of corn from the U.S. and began seeing a price drop in the value of corn. After researching the case, our Firm began taking on clients and signed contingency fee agreements for prosecution of their claims. Counsel signed clients between December 2015 and August 2016.
- 12. The Firm filed four cases in the District Court for the Fourth Judicial District in Hennepin County on behalf of our clients under Civil Action Numbers 27-CV-16-5970, 27-CV-16-9121, 27-CV-16-13118, 27-CV-16-14683, in April, June, August, and October 2016.
- 13. Starting in 2016, after the Plaintiff Fact Sheet order was entered, the Firm spent more than one hundred hours contacting and meeting with farmers to obtain the documentation required by the order, knowing that if the information was not produced by the court deadlines, defense counsel could file a motion to dismiss the individual cases barring our clients from ever recovering. After the long discovery process and monitoring the status of the bellwether cases around the country, the Firm became aware in September 2017 about the potential settlement of all cases around the country. With the understanding there was settlement committees comprised of both individual and class action attorneys, it was believed there would be two settlement tracks. In early 2018 we became aware there would be only one Class Actions Settlement encompassing our filed cases and we began advising clients of the Settlement and what we believed was in their best interest.
- 14. Overall, I kept informed about this case by communicating with other counsel, reading court pleadings and public reports, and participating in status calls, so that I could advise

my clients as to the progress of the case—and I did keep them so informed, including by phone calls, emails, and in person meetings.

- 15. I believe the settlement is fair and in the best interests of our clients and we have recommended to our clients that they participate in the class action settlement. Accordingly, the Firm anticipates that all of the Firm's clients will timely complete settlement submissions. Thus, in addition to prior time spent litigating the case and advising clients, our Firm has—and will continue—to assist class members with the settlement process and will do so until all payments are made and the litigation is closed.
- 16. The Firm drafted complaints, completed and served plaintiff fact sheets, updated clients, and completed all other tasks necessary to prosecute these cases.
- 17. The time and expense figures above include 110.1 hours (\$21,585.00 at our usual and customary rates) and \$72.86 in costs and expenses submitted by my Firm to the Minnesota Co-Lead Counsel as Common Benefit Work and Common Benefit Expenses, in compliance with the Minnesota Common Benefit Order (entered by Judge Sipkins on December 7, 2015), and the Common Benefit Rules adopted by Co-Lead Counsel pursuant thereto.
- 18. The firm (and, to the best of my knowledge, non-class counsel generally) have received little to no guidance on certain issues related to representation of clients, including how our clients' fees and expenses will be paid in this litigation in light of the recent preliminarily approved class action settlement. I am not certain if plaintiffs' leadership has even broached these subjects with the defense or the court. Since I am left to conjecture how these issues will be resolved, I am not able to consult with my clients effectively.
- 19. The Firm has been advised by Minnesota Co-Lead Counsel that Minnesota Co-Lead Counsel's Fee & Expense Application in this matter will include and seek an award for all

approved Common Benefit Work and Common Benefit Expenses. As of today, however, I have not been provided the final word on how much of the Firm's common benefit time and expense has been so approved.

- 2. I am a partner of Wagner Reese, LLP (hereinafter "the Firm"). I am authorized to submit this declaration on the Firm's behalf.
- 3. I submit this declaration in support of the Pavlack Law Fee & Expense Application ("the Application"), filed pursuant to Section 7.2.1 of the Agrisure Viptera/Duracade Class Settlement Agreement (the "Settlement Agreement") in *In Re: Syngenta AG MIR 162 Corn Litigation*, a multi-district litigation consolidated in the United States District Court for the District of Kansas before Hon. John W. Lungstrum (MDL-2591), and *In Re: Syngenta Litigation*, a Minnesota Consolidated Proceeding consolidated in the Fourth Judicial District Court, Hennepin County, Minnesota, before Hon. Laurie Miller (formerly Hon. Thomas Sipkins) (File Nos. 27-CV-15-3785 & 27-cv-15-12625).
- 4. Together with Pavlack Law, Wayne Lennington, and Pen Cosby, the Firm represents 49 clients in the Argisure/Viptera litigation against Syngenta on a contingency basis. In written fee agreements, with three exceptions, each of these clients agreed to pay 40% of any recovery in this matter as a contingent fee, covering both legal fees, and further agreed to a division of those fees between the Firm and its co-counsels. Three clients, Craig Armstrong, Neil Armstrong, and C&N Armstrong Farms Ltd., have agreed to all of the same terms except that they agreed to pay 20% of any recovery.
- 5. Because our representation is on a contingency basis, timekeepers at the Firm did not precisely track the time spent on this litigation since it was not anticipated this would be necessary. However, based on the review of e-mails, notes, case management software, and other client and litigation materials, we have retrospectively estimated time spent on this litigation as set forth herein. Any reference to dates in Exhibit A are estimates based on the review of this information.

- 6. Pavlack Law has acted as lead counsel in this matter and will file an Application for a Fee & Expense Award based on the clients' gross recoveries under the Settlement Agreement and the private fee contracts with each such client. The Firm supports and joins that Application for contract fees.<sup>1</sup>
- 7. Wagner Reese, LLP was founded by partners Stephen M Wagner and Jason R. Reese in 2000. The Firm handles personal injury, product liability, complex litigation, and class action matters throughout Indiana and Illinois. Mr. Wagner was admitted to the Indiana bar in 1994 and has taken numerous cases to jury trial throughout his career. He was named the Trial Lawyer of the Year by the Indiana Trial Lawyers' Association (ITLA) in 2006 and is an elected member of the ITLA Board of Directors. Jason R. Reese was admitted to the bar in 1997 and is currently licensed in Indiana and Illinois. Mr. Reese has extensive jury trial experience throughout his career and has been repeatedly recognized by his peers as one the best trial lawyers in Indiana. His recognition began in 2003 when the Indiana State Bar Association named him "Outstanding Young Lawyer of the Year." In 2016 and 2018, Mr. Reese's peers voted him a Top 50 Super Lawyer for the State of Indiana.
- 8. Much of the Firm's time was spent ensuring that its 49 clients complied with the Minnesota Court's Order that all plaintiffs complete a Plaintiff Fact Sheet (PFS) and produce voluminous documents proving corn production. Our key responsibilities included (1) providing steady updates to our clients throughout the duration of the Syngenta litigation, by way of email, letter correspondence, and telephone calls, and (2) handling the bulk of incoming client document

processing to ensure PFS compliance. This undertaking included scanning, emailing, or mailing originals, filing, and updating our master client spreadsheet to ensure PFS compliance. I estimate that the Firm's actual time spent on this matter for our forty-nine (49) clients from September 2015 to present is 186.5 hours, which is \$24,300 at our usual and customary hourly rates.

- 9. The individuals in the Firm who worked on this matter are:
  - A. Stephen M. Wagner, Partner, admitted to practice in 1994, hourly rate \$450-\$700, depending on the matter
  - B. Jason R. Reese, Partner, admitted to practice in 1997, hourly rate \$450-\$700, depending on the matter
  - C. Katelyn Blankenship, litigation staff, hourly rate, \$75
  - D. Meg Spiker, litigation staff, hourly rate, \$75
  - E. Gary Cauble, litigation staff, hourly rate, \$75
- 10. I kept informed about this case by communicating with Pavlack Law, reading court pleadings and public reports, and participating in status calls, so that I could advise my clients as to the progress of the case and I did keep them so informed including by phone calls, emails, video messages, and in-person meetings.
- 11. Since the settlement was approved, the Firm has continued to work closely with Pavlack Law to inform our clients about the settlement and the claims form process. These updates were given by way of correspondence, along with email updates and phone calls.

I declare under penalty of perjury pursuant to 28 U.S.C. § 1746 that the foregoing is true and correct.
