**TOUPS/COFFMAN PLAINTIFFS' COUNSEL'S SUPPLEMENT TO THEIR MOTION
FOR AN AWARD OF ATTORNEYS' FEES AND EXPENSES**

TO THE HONORABLE UNITED STATES DISTRICT COURT:

Pursuant to the Court's July 18, 2018 Order ("Order") (Doc. No. 3613), Attorneys Mitchell A. Toups and Richard L. Coffman, on behalf of themselves and co-counsel, Richardson, Patrick, Westbrook & Brickman, LLC, and the referral counsel listed in Exhibit D (collectively, "Toups/Coffman Plaintiffs' Counsel"), file this Supplement¹ to their Motion for an Award of

Attorneys' Fees and Expenses ("Fee and Expense Motion") (Doc. No. 3566) and Supporting Memorandum (Doc. No. 3567).

Toups/Coffman Plaintiffs' Counsel do so without waiving their objections to being required to report their time and expenses since they are not class counsel, they have contingent fee contracts with each of their 9400+ corn producer clients (pursuant to which they should be compensated), and they were not required to keep and maintain contemporaneous time records under any Court order.

Toups/Coffman Plaintiffs' Counsel further object to the Order insofar as it unilaterally accelerates the briefing schedule on the attorneys' fee and expense motions (and presumably their determination) before the conclusion of the settlement claim filing period and the tabulation of settlement claims filed by corn producers represented by individual counsel versus claims filed by corn producers not represented by individual counsel (*i.e.*, class members represented by class counsel).

TOUPS/COFFMAN PLAINTIFFS' COUNSEL'S SUPPLEMENT

In its Order, the Court required counsel to supplement their fee and expense motions with Court-designated spreadsheets categorizing the time and expenses counsel incurred working on this litigation. *Id.* at ¶2. Toups/Coffman Plaintiffs' Counsel hereby supplement their Fee and Expense Motion with the following Court-ordered spreadsheets:

Concurrent with filing this Supplement, and pursuant to the Order, Toups/Coffman Plaintiffs' Counsel submitted these spreadsheets to the Special Masters in Excel format.

**RESPONSE TO THE COURT'S REQUEST FOR SUGGESTIONS PERTAINING TO
THE AWARD AND DISTRIBUTION OF ATTORNEYS' FEES**

In its Order, the Court also invited counsel to submit "any additional information they believe is relevant to determining (a) what portion of the Settlement Amount should be allocated to attorney fees and expenses, and (b) the appropriate allocation of that amount among plaintiffs' counsel." *Id.* at ¶2. Without waiving their above-referenced objection and their right to be compensated under the terms of the contingent fee agreements with each of their 9400+ clients, Toups/Coffman Plaintiffs' Counsel respectfully do so here.

The following chart summarizes the fee and expense applications filed with the Court as of the date this Supplement was filed.

In light of the number of lawyers who worked on this litigation, the time spent working on the litigation, the amount of expenses counsel advanced to prosecute the litigation, the number of corn producers who got involved in the litigation and filed individual cases, the amount of the recovery, and the number of corn producer settlement claims filed to date, Toups/Coffman Plaintiffs' Counsel suggest that the Court allocate \$500 million of the settlement to pay the attorneys' fees and expenses of *all counsel* who complied with the Court's April 10, 2018 Preliminary Approval Order and filed a fee and expense motion.

In light of the above, counsel's collective extraordinary efforts, and the amount of the recovery, Toups/Coffman Plaintiffs' Counsel believe \$500 million is a reasonable amount to be allocated

for attorneys' fees and expenses. It's also consistent with the requested fees and expenses in the above chart. Handling attorneys' fees and expenses in this manner (*i.e.*, a settlement carve-out from which all counsel who worked on the litigation would be compensated) will put all corn producer settlement claimants on equal footing.

Moreover, since the total requested attorneys' fees and expenses are within 20% of \$500 million (assuming, of course, the Court sets aside this amount), Toups/Coffman Plaintiffs' Counsel further believe that it is well within the realm of possibility that counsel collectively could reach an agreement regarding the division of the \$500 million fee and expense award. Toups/Coffman Plaintiffs' Counsel suggest such an agreement could (and should) be achieved via mediation. A successful mediation would obviate any potential fee disputes between counsel that would only prolong the litigation.

Toups/Coffman Plaintiffs further suggest that the mediation be conducted by Retired Judge W. Royal Furgeson, Jr. in Dallas, Texas, at the earliest possible date. Judge Furgeson is a respected jurist who would bring a fresh perspective and objectivity to the process. Having formerly served as a federal judge and on the Judicial Panel on Multidistrict Litigation, Judge Furgeson is well-versed in the law, and imminently qualified to mediate the division of attorneys' fees and expenses in this MDL proceeding. A copy of Judge Furgeson's biography is attached for the Court's convenience as Exhibit E.

Pending the mediation, Toups/Coffman Plaintiffs further suggest that all deadlines pertaining to the fee and expense motions be suspended.

**SUPPLEMENTAL DECLARATION OF MITCHELL A. TOUPS IN SUPPORT OF
TOUPS/COFFMAN PLAINTIFFS' COUNSEL'S FEE AND EXPENSE MOTION**

Pursuant to 28 U.S.C. § 1746, I, Mitchell A. Toups, declare as follows:

1. I am a partner of Mitchell A. Toups, Ltd., ("Toups"). As a partner of Mitchell A. Toups, Ltd. and Weller, Green, Toups & Terrell, L.L.P., I am authorized to submit this Declaration on behalf of Mitchell A. Toups, Ltd. and Weller, Green, Toups & Terrell, L.L.P.

2. I, along with Richard L. Coffman, of The Coffman Law Firm, co-counsel, Richardson, Patrick, Westbrook & Brickman, LLC, and our referral counsel listed in Exhibit "D" (collectively, "Toups/Coffman Plaintiffs' Counsel") represent over 9,400 United States corn producers in this litigation. We have a signed contingent fee contract with each and every client

we represent in this litigation. Our clients comprise the plaintiff group commonly known as the Toups/Coffman Plaintiffs.

3. I make this declaration based on my personal knowledge, and if called to testify to the contents hereof, I could and would competently do so. I respectfully submit this Supplemental Declaration for the sole purpose of supporting The Toups/Coffman Plaintiffs' Counsel's Motion for an Award of Attorneys' Fees and Expenses ("Fee and Expense Motion"), including my prior Declaration), and the corresponding Supplement thereto.

4. As previously stated, Toups/Coffman Plaintiffs' Counsel are entitled to attorneys' fees calculated using the contingent fee percentages set forth in each of our client's contracts. Based on our clients' contractual contingent fee percentages, Toups/Coffman Plaintiffs' Counsel estimate that Toups/Coffman Plaintiffs' settlement claims will comprise at least 10% of the value of the claims filed. At this rate, our attorneys' fees under the contingent fee contracts with our clients will be \$34 million. These attorneys' fees, of course, will increase if the Toups/Coffman Plaintiffs' settlement claims comprise greater than 10% of the value of the claims filed.

5. Likewise, per the contracts with our clients, Toups/Coffman Plaintiffs' Counsel are entitled to recover their reasonable expenses incurred to prosecute the litigation on behalf of Toups/Coffman Plaintiffs. Since Toups/Coffman Plaintiffs' Counsel filed their Fee and Expense Motion, their total reimbursable litigation expenses have increased to \$392,056.14. The increased expenses are due to Toups/Coffman Plaintiffs' Counsel's ongoing and continuing efforts to contact and work with their clients to timely file their settlement claim forms. Each Toups/Coffman Plaintiffs' Counsel law firm's expenses to date, including mine, are set forth in their individual Court-ordered spreadsheets categorizing the time and expenses incurred by counsel working on

this litigation (“Spreadsheets”) (July 18, 2018 Order (Doc. #3613)). See Supplement (Exhibits A-D).

6. Touns/Coffman Plaintiffs’ Counsel are not class counsel in this litigation, but rather, counsel representing corn producers under individual contingent fee contracts. As such, Touns/Coffman Plaintiffs’ Counsel were not required to keep and maintain contemporaneous non-common benefit time records under any Court order. That said, since filing our Fee and Expense Motion, and as a further cross-check, we have continued to diligently reconstruct the time spent working on the litigation from our records to be as precise as possible, as well as supplement it with time spent working on the litigation since filing the Fee and Expense Motion and estimated future time. Each law firm’s reconstructed and updated time incurred on this litigation is also set forth in their Spreadsheets.

7. Accordingly, Touns/Coffman Plaintiffs’ Counsel should be awarded a minimum of \$34 million of attorneys’ fees and an expense reimbursement of \$392,056.14 pursuant to the terms of the contingent fee contracts with their clients, the Touns/Coffman Plaintiffs.

8. In the alternative, should the Court abrogate the contingency fee agreements between Touns/Coffman Plaintiffs’ Counsel and Touns/Coffman Plaintiffs (for which there is no law justifying same), Touns/Coffman Plaintiffs’ Counsel should be awarded attorneys’ fees in the amount of at least \$30 million (with a minimum 1.5 multiplier) and an expense reimbursement (\$392,056.14) based on the time incurred and litigation expenses advanced in prosecuting the litigation on behalf of Touns/Coffman Plaintiffs.

9. Or, in the further alternative, Touns/Coffman Plaintiffs’ Counsel should be awarded attorneys’ fees equal to a minimum of 10% of the total amount set aside to pay all attorneys’ fees

(plus an expense reimbursement of \$392,056.14) since Toups/Coffman Plaintiffs are anticipated to file at least 10% of all of the settlement claims filed.

10. I declare under penalty of perjury pursuant to 28 U.S.C. § 1746 that the foregoing is true and correct.

2. I have personal knowledge of the statements in this Supplemental Declaration and, if called as a witness, I could, and would, testify competently about them. As a shareholder in, and President of, the Coffman Law Firm, I am authorized to submit this Supplemental Declaration on

behalf of the Coffman Law Firm. I make it in further support of Toups/Coffman Plaintiffs' Counsel's Motion for an Award of Attorneys' Fees and Expenses ("Fee and Expense Motion") (including my prior Declaration), and the corresponding Supplement to it.

6. Accordingly, Toups/Coffman Plaintiffs' Counsel should be awarded a minimum of \$34 million of attorneys' fees and an expense reimbursement of \$392,056.14 pursuant to the terms of the contingent fee contracts with their clients, the Toups/Coffman Plaintiffs.

7. In the alternative, should the Court abrogate the contingency fee agreements between Toups/Coffman Plaintiffs' Counsel and Toups/Coffman Plaintiffs (for which there is no law justifying same), Toups/Coffman Plaintiffs' Counsel should be awarded attorneys' fees in the amount of at least \$30 million (with a minimum 1.5 multiplier) and an expense reimbursement (\$392,056.14) based on the time incurred and litigation expenses advanced in prosecuting the litigation on behalf of Toups/Coffman Plaintiffs.

8. Or, in the further alternative, Toups/Coffman Plaintiffs' Counsel should be awarded attorneys' fees equal to a minimum of 10% of the total amount set aside to pay all attorneys' fees (plus an expense reimbursement of \$392,056.14) since Toups/Coffman Plaintiffs are anticipated to file at least 10% of all of the settlement claims filed.

W. Royal Furgeson, Jr.

W. Royal Furgeson, Jr. retired as a United States District Judge in 2013 after 19 years on the bench. A graduate of Texas Tech University in 1964 and the University of Texas School of Law in 1967, he was named the founding Dean of the UNT Dallas College of Law in 2012 and assumed the position in mid-year 2013. From time to time, depending on availability and on his law school responsibilities, he serves as a mediator or arbitrator, to assist parties in the resolution of complex cases.

After law school, he served the U.S. Army for two years, attaining the rank of Captain. Following a tour in Vietnam, he returned to Lubbock as law clerk to the Honorable Halbert O. Woodward.

Before taking the bench, Judge Furgeson practiced law for twenty-four years with the Kemp Smith law firm in El Paso, Texas. During that time, he became a fellow of the American College of Trial Lawyers, an elected member of the American Law Institute, president of the El Paso Chapter of the American Board of Trial Advocates, president of the El Paso Bar Association and chair of the United Way of El Paso.

During his time on the bench, he was a panel judge on the Judicial Panel on Multidistrict Litigation, president of the Federal Judges Association, and chair of the Judicial Resources Committee of the Judicial Conference of the United States.

His honors include the Distinguished Alumnus Award by the Texas Tech Alumni Association, the West Texas Legal Legend Award by the Texas Tech University School of Law, the Leon Green Award by the Texas Law Review, the Faculty Award by the University of Texas School of Law, Honorary Serjeant of the William "Mac" Taylor, Jr. American Inn of Court, the Morris Harrell Professionalism Award by the Dallas Bar Association and the Texas Center for Legal Ethics and Professionalism, and Jurist of the Year, Texas Chapter of ABOTA. In 2016, he was named as one of the fifty Lions of the Texas Bar by the Texas Lawbook.

Judge Furgeson is married to Marcellene Malouf, a graduate of St. Mary's University School of Law, who has been the Executive Director of the D.I.I. Asbestos Trust since 2004, after 20 years in the practice. Together, they have nine children and 14 grandchildren.
