DECLARATION OF ERIC D. BARTON OF WAGSTAFF & CARTMELL, LLP

I, Eric D. Barton, declare and state as follows:

- 1. I am a partner at the law firm of Wagstaff & Cartmell, LLP, and am duly authorized by the partners of the firm to make this declaration on its behalf.
- 2. I submit this in support of my firm's Motion for Attorneys Fees and Expenses for Individual Client Representation. I have personal knowledge of the matters set forth in this declaration, and, if called as a witness, could and would testify competently thereto.
- 3. My firm has acted as counsel for corn producers in this litigation entirely on a contingent basis.
- 4. A firm resume, and the experience, credentials, and background of the attorneys and staff who have worked on this case on behalf of the firm's clients, are submitted with the Declaration of Tyler W. Hudson in support of common benefit fees and expenses submitted by the Minnesota Co-Lead counsel.
- 5. Wagstaff & Cartmell, LLP, has signed contingency agreements with 704 producer clients who filed actions in the Minnesota Consolidated Action. A list of these clients, their case numbers, and the status (at least as known to Wagstaff & Cartmell at this time) of their submission of claims in the settlement, is attached hereto as Exhibit A. The firm's fee agreements with nearly all of its clients provided a 33 percent contingent fee in the event of a recovery by the client. A very small number of contracts contained

slightly lower percentages, ranging from 25 to 30 percent. Copies of the firm's fee contracts with its clients are available upon request.

- 6. The vast majority, nearly 90 percent, of Wagstaff & Cartmell's clients have already submitted claims in the settlement, many with assistance from Wagstaff & Cartmell, and Wagstaff & Cartmell is unaware of any of its clients who have chosen to opt out, or object, to the settlement.
- 7. Wagstaff & Cartmell drafted, filed, and served complaints for its 704 Minnesota plaintiffs, which it was able to combine into 9 separate actions under the liberal joinder rules in place in Minnesota. In order to prepare and file those complaints, Wagstaff & Cartmell spend a considerable amount of time with each of its clients reviewing documents and FSA 578 forms to ensure that it was naming and filing on behalf of the proper persons or entities with standing to seek damages. This work ultimately benefitted the clients both in later completing their Plaintiff Fact Sheets, and also in expediting their submission of claims in the settlement. This work was not included in any submission of time for common benefit purposes. Wagstaff & Cartmell has also spent considerable time assisting clients and communicating with clients about the settlement process and actually assisting clients in submitting their claims.
- 8. In addition, Wagstaff & Cartmell lawyers also spent a considerable amount of time evaluating, researching, and analyzing which of the potential venues were most optimal for its clients. This also included evaluating, meeting with, and talking with various group and teams of other lawyers representing clients in different venues. None

of that work was submitted for reimbursement under a common benefit application, but it was performed on a contingent basis in the service of the Firm's 704 clients. Ultimately, after initially being appointed as a member of the Plaintiff's Steering Committee in the MDL in the District of Kansas, Wagstaff & Cartmell made the decision to recommend to its clients that they file their cases individually in Minnesota state court in Hennepin County. Wagstaff & Cartmell was appointed by Judge Sipkins to the Plaintiff's Executive Committee in Minnesota, and the firm subsequently elected to withdraw from the Plaintiff's Steering Committee in the MDL, so that it could focus its attention and efforts on the litigation in Minnesota.

- 9. While stating a total number of corn acres represented by W&C's producer clients can be misleading since many clients have fractional shares in certain acres or they do not produce corn on all of their acres every year, W&C has attempted to account for fractional shares among its clients and estimates the total acres of corn on an average, annual basis between 2013 and 2017, within its client group to be over 250,000 acres. The total number of acres in which the firm's clients have some interest in the proceeds from the acreage is a much higher number.
- 10. Wagstaff & Cartmell has separately tracked its time and expenses spent solely in the service of individual clients not for the Common Benefit under the direction of Minnesota Co-Lead Counsel throughout this litigation. I have reviewed our firm's time entries billed to individual (non-Common Benefit) representation since the inception of our work in this case, including our pre-suit investigation work, and after

eliminating or reducing time entries that I deemed to be either duplicative of common benefit work separately submitted (including Plaintiff Fact Sheet work), or, work not performed in the representation of our 704 individual clients, our Firm spent a total of 3,107.20 hours in non-common benefit work on behalf of our individual clients. Using the same rates applied to our lodestar for Common Benefit purposes, those hours translate to a lodestar that is separate from and in addition to its common benefit work, of \$1,194,663.50.

- 11. Wagstaff & Cartmell met many of its clients in face-to-face meetings and had numerous, individual calls and communications with its clients through the course of the litigation, keeping the clients informed about the case and their options and obligations in the litigation. In addition, the task of gathering documents and completing Plaintiff Fact Sheets for all of the Firm's clients was a strenuous and time-consuming task.
- 12. Wagstaff & Cartmell was aided significantly in the representation of its individual clients by the services and professionalism of numerous associating counsel located often in close proximity to the clients. A list of the lawyers and firms with whom W&C and its clients worked closely in the Syngenta litigation is attached as Exhibit B. These associated counsel played a key role in communicating with the firm's clients throughout the course of the litigation about various aspects of the case, including the clients' obligations under the Court's orders regarding Plaintiffs Fact Sheets. These lawyers were not asked to keep track of their time for purposes of submitting it for fee

awards, as their sole expectation of compensation was through appropriate sharing of fees under the clients' contingency fee contracts with our Firm. However, based upon our Firm's interactions with the associating lawyers, it is very reasonable to estimate that these lawyers collectively spent many hundreds of hours assisting, advising, and communicating with the Firm's clients throughout the pendency of this case.

13. After exercising billing judgment and making billing reductions based on a review of my firm's records, the details of which are available upon request, the total non-Common Benefit lodestar for my law firm is \$1,194,663.50. A breakdown of the lodestar is provided below.

- 14. Given the substantial amount of time, resources, and capital that our Firm dedicated to the Syngenta litigation, we were necessarily precluded from taking on other work from early 2015 through mid-2017.
- 15. My firm also seeks an award of \$14,977.50 in non-Common Benefit Expenses, i.e., those incurred solely for filing and serving the Complaints through which our firm's 704 plaintiff clients brought their claims in the Minnesota Consolidated Action. A detailed description of those expenses is attached as Exhibit C hereto.
