DECLARATION OF DANIEL E. GUSTAFSON IN SUPPORT OF MINNESOTA CO-LEAD COUNSEL'S SUPPLEMENT TO THE JOINT MOTION FOR APPROVAL OF COMMON BENEFIT AWARDS

I, Daniel E. Gustafson, declare and state as follows:

- 1. I am a Member at the law firm of Gustafson Gluek PLLC, and am duly authorized to make this declaration.
- 2. I submit this declaration in support of the Supplement to Minnesota Co-Lead Counsel's Joint Motion for Approval of Common Benefit Awards and in support of my firm's contribution to Minnesota Co-Lead Counsel's Joint Motion for Approval of Common Benefit Awards. I have personal knowledge of the matters set forth in this declaration, and, if called as a witness, I could testify to the matters set forth in this declaration.
- 3. On July 10, 2018, pursuant to the Settlement Agreement and the Order for Preliminary Approval, Minnesota Co-Lead Class Counsel filed a:
 - a. Joint Motion for Approval of Common Benefit Awards;

- b. Memorandum in Support of the Motion for Approval of Common Benefit Awards;
- c. Declaration of Daniel E. Gustafson In Support of the Motion for Approval of Common Benefit Awards (along with Exhibits 1-16);
- d. Declaration of Karl Cambronne in Support of the Motion for Approval of Common Benefit Awards;
- e. Declaration of Amanda M. Williams in Support of the Motion for Approval of Common Benefit Awards.
- 4. Pursuant to the MDL Court's July 18, 2018 Order Regarding Attorney Fee Submission, ECF 3613, I requested that each firm that was included on the Exhibit 13 of my Declaration filed on July 10, 2018, create a spreadsheet as ordered by the MDL court which would break out their Audited Lodestar (as found on Exhibit 13) and Expenses into the various categories specified on the MDL Court's Approved Chart attached to its July 18, 2018 Order. I also asked them to include any time that was previously not included as part of their Total Lodestar (as set out on Exhibit 13 of my July 10, 2018 Declaration and as set out in each of their individual firm declarations attached to my July 10, 2018 Declaration) in the "Other Work" column of the MDL Court's Approved Chart. As there was not a column for "Other Expenses" we did not include on the Court's Approved Chart any expenses that were not approved as Common Benefit expenses.
- 5. When we received these supplemental charts from our co-counsel, we did not further audit them to ensure that the audited time or expenses were correctly categorized. Rather, Co-Lead Counsel simply checked to make sure that the total Audited Lodestar and Expenses set forth on the Court-Approved Chart submitted herewith matched the totals that were set forth in Exhibit 13 of my earlier declaration.

- 8. Attached as Exhibit C is the Court-Approved Spreadsheet of Total Audited Lodestar and Expenses on behalf of Daniel M. Homolka, P.A.
- 9. Attached as Exhibit D is the Court-Approved Spreadsheet of Total Audited Lodestar and Expenses on behalf of Gustafson Gluek PLLC.
- 10. Attached as Exhibit E is the Court-Approved Spreadsheet of Total Audited Lodestar and Expenses on behalf of Kemp, Jones & Coulthard, LLP.

¹ During the process of re-categorizing the time and expenses for this firm, it became clear that a \$10,000 assessment paid by the Byrd firm was inadvertently omitted from the chart set forth on Exhibit 13 of my July 10, 2018 Declaration. We have now included that assessment payment. As a result, the expense totals for the Byrd firm and overall, do not match those found in Exhibit 13 because they have been adjusted to account for this new information.

² During the process of re-categorizing the time and expenses for this firm, it became clear that a \$25,000 assessment paid by the Lockridge firm was inadvertently omitted from the chart set forth on Exhibit 13 of my July 10, 2018 Declaration. We have now included that assessment payment. In addition, the Lockridge firm made some adjustments to their expenses that lowered the earlier total. As a result, the expense totals for the Lockridge firm and overall, do not match those found in Exhibit 13 because they have been adjusted to account for this new information.

- 17. Attached as Exhibit L is the Court-Approved Spreadsheet of Total Audited Lodestar and Expenses on behalf of Zimmerman Reed LLP.
- Declaration, I provided those firms with the Court-Approved Excel Spreadsheet and indicated that they should complete the spreadsheet by including any time approved as Plaintiff Fact Sheet or Bellwether time (as set forth on Exhibit 14 of my July 10, 2018 Declaration) in the column designated "Approved Common Benefit Work" and include any of their other time in the Column designated "Other Work." As many of these firms were included in the separate submissions of other law firms, such as the Watts Guerra submission or Paul Byrd submission, or filed their own separate fee submission, I instructed those firms to file their supplemental Court-Approved spreadsheet with those separate filings. For firms that did not do a separate filing, I instructed them to file the Court-Approved spreadsheet with a declaration supporting that time by no later than August 3, 2018. We did not collect any supplements from these firms.

19. However, in working with these firms, there were a few firms who had

inadvertently not been included on Exhibit 14 to my July 10, 2018 declaration. As such, I

am attaching an Amended Exhibit 14, with the changes made in red.

20. Because of the separate filings, there is certainly overlap in the time

submitted by these various petitions and supplements. We expect the Courts (and Special

Masters) will put in place a procedure to assure that no duplicate recoveries occur.

21. Because of the time constraints during the audit process and the lengthy time

involved in the auditing, the time for Gustafson Gluek PLLC for the time period April 1,

2018 to July 31, 2018 was not included and therefore not submitted as approved common

benefit time. Most of this time involved settlement administration work or audit committee

work. We have included that time as "other time" in the Court's supplemental spreadsheet.

I declare under penalty of perjury pursuant to 28 U.S.C. § 1746 that the foregoing

is true and correct.
